

School Readiness

While helping children prepare for school, the School Readiness (SR) program offers financial assistance to help children from low-income families to receive high quality child care. Parent(s)/guardian(s) must be working or participating in an education activity for at least 20 hours per week and be at or below 150 percent federal poverty level for their family size.

Other children may be eligible if they have special needs or are at risk of abuse, neglect or abandonment, or if their parents are homeless, victims of domestic violence or are low-income migrant families or farm workers.

Voluntary Prekindergarten

Florida was one of the first states in the country to offer free Voluntary Prekindergarten (VPK). Children living in Florida and who turned 4 years old on or before Sept. 1 are eligible. Parents can postpone enrolling their child until the following year when their child is 5 years old if the child's fourth birthday falls Feb. 2 through Sept. 1 in a calendar year

Families can apply for VPK by providing documentation of their Florida residency and their child's date of birth.
